Contract of Husband's Chastity

- A. It is in the interest of both the Wife and Husband to have a strong and loving marriage.
- **B**. The Husband acknowledges his deep need for Wife's loving control and guidance to modify Husband's behavior by controlling Husband's sexual needs with a lockable chastity device.
- C. Therefore, Husband desiring to improve himself and the marital relationship, has wisely concluded that he should agree to a <u>Contract of Chastity</u> for the benefit of Wife, Husband and marriage.
- **D**. This contract places control of the Husband's sexual needs in Wife's loving hands.
- **E**. Husband surrenders <u>complete control</u> of his orgasm and masturbation to Wife. Wife alone has the power to permit Husband an orgasm and/or masturbate under Wife's supervision.
- **F**. Wife in exchange, offers to fulfill Husband's need for loving control of Husband's sexual needs under this contract to modify Husband's behavior as Wife deems necessary.

1. Definitions

Throughout this contract, these terms are used with following definitions.

- 1.1 Chastity: Prevention of <u>all</u> kinds of sexual activities, including <u>sexual intercourse</u> and <u>self masturbation</u>.
- 1.2 Chastity Device: A lockable, wearable device designed to keep Husband's chastity and to prevent touching Husband's genitals.
- 1.3 Husband: The individual who will wear the device according to this contract, and who is to keep one's own chastity.
- 1.4 Wife: The individual who will lock the device and will hold the key according to this contract. Wife is the Keyholder.
- 1.5 Orgasm: An ejaculatory release of semen.
- 1.6 Masturbation: Self stimulation of Husbands genitals to achieve sexual pleasure

2. Husband's obligation

Husband is under the following obligations.

- 2.1 The Husband wears the chastity device at any time or place the Wife specifies. The Husband may not object.
- 2.2 The Husband is prohibited to have any sexual intercourse without the Wife's permission.
- 2.3 The Husband is <u>prohibited</u> any contact with Husband's genitals, by anyone without Wife's specific permission, regardless of whether an orgasm occurs or not.
- 2.4 The Husband is prohibited any orgasm Husband has by any means that occurs without Wife's specific permission.
- 2.4 The Husband is <u>prohibited</u> to masturbate without the Wife's permission.
- 2.5 The Husband is <u>prohibited</u> to make efforts to remove the chastity device.
- 2.6 The Husband has the responsibility to maintain the chastity device cleanliness under Wife's supervision.

- 2.7 The Husband is <u>never</u> permitted to leave from under the Wife's control without the Wife's special permission, when the chastity device is removed by the Wife temporally.
- 2.8 The Husband <u>must</u> follow recommendations made by Wife that enhance his well being, health and behavior modification. Including, but not limited to diet and exercise.

3. Wife's obligation

Wife is under following obligations.

- 3.1 The key will <u>always</u> be under the supervision and control of the Wife.
- 3.2 The Wife has the obligation to pay attention of the Husband's health condition and arrange necessary suitable treatment when any disorders are identified on the Husband's body.
- 3.3 The Wife will supervise and let the Husband clean the chastity device at regular intervals, at least once each 4 days.
- 3.4 Unless Wife deems necessary, Wife never discloses the fact that the Wife controls the Husband's sexual needs to modify Husband's behavior.
- 3.5 Wife will not keep Husband in a Chastity Device permanently, unless Wife deems necessary.

4. Duration of the contract

- 4.1 This contract is valid for a one year period, renewable in one year increments.
- 4.2 Contract may be extended and renewed indefinitely with only Wife's signature and date. Additional terms continue.
- 4.3 Wife retains the original contract and supersedes all duplicates.

5. Cancellation of the contract

- 5.1 The Husband never requests the cancellation of the contract except the following cases.
 - 5.1.1 The relationship between the Husband and the Wife is cleared.
 - 5.1.2 Either the Husband or the Wife is unable to execute ones obligation due to long-term illness or other reasons.
 - 5.1.3 Either the Husband or the Wife died.
 - 5.1.4 It becomes obvious that wearing the chastity device causes serious problems to Husbands health.

This contract of Husband's Chastity is entered into voluntarily by both parties without duress of any kind.

5.2 Wife may cancel the contract unconditionally at any time Wife deems
